## Application by an Organization to Use the N4 NATO Native and Non-Native Speech corpus distributed by the Linguistic Data Consortium

\_\_\_\_\_ ("User"), an organization engaging in language education and research agrees to use the speech and text data (the "Data") designated as N4 NATO Native and Non-Native Speech and distributed by the Linguistic Data Consortium (LDC) subject to the following understandings, terms and conditions.

### 1. Permitted uses

1.1. The Data may only be used for linguistic education and research, including but not limited to information retrieval, document understanding, machine translation, or speech recognition.

1.2. User shall not copy, redistribute, resell, transmit, publish or otherwise use the Data for any other purpose.

### 2. Copyright Notice and Disclaimer

2.1. The Data is the property of the University of Pennsylvania and is protected by copyright. In no event shall User publish, retransmit, redistribute, or otherwise reproduce any or all of the Data in any format to anyone, except as allowed in Section 1 of this agreement.
