

User License Agreement for ETS Corpus of Non-Native Written English LDC2014T06

Application by an Organization to use **ETS Corpus of Non-Native Written English LDC2014T06** distributed by the **Linguistic Data Consortium (LDC)**

_____ (“**User**”), an organization engaging in language education and research agrees to use the text data designated as the **ETS Corpus of Non-Native Written English LDC2014T06** (the “**Data**”) and distributed by LDC subject to the following understandings, terms and conditions.

1. Permitted and Prohibited Uses

1.1. User agrees that the **Data** may only be used for non-commercial linguistic education, research and technology development purposes, such as tasks of native language identification, grammatical error detection, and learner corpus analysis, to the extent such tasks are non-commercial. Without limiting the foregoing, the **Data** may not be used for any commercial purpose whatsoever and nothing in this Agreement shall be construed as granting User any right to use the **Data** for any commercial purpose.

1.2. In addition, User shall not publish, retransmit, display, redistribute, reproduce or commercially exploit the **Data** in any form, except that User may include limited excerpts from the **Data** in articles, reports and other documents describing the results of User’s linguistic education and research.

2. Ownership and Disclaimer

2.1. The **Data** is the property of Educational Testing Service (“**ETS**”) and may be protected by applicable copyright law.

USER ACKNOWLEDGES AND AGREES THAT The **ETS Corpus of Non-Native Written English LDC2014T06** IS PROVIDED ON AN “AS-IS” BASIS AND THAT ETS, LDC AND ITS HOST INSTITUTION THE UNIVERSITY OF PENNSYLVANIA MAKE NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR CONFORMITY WITH WHATEVER DOCUMENTATION IS PROVIDED. User acknowledges and agrees that ETS is an intended third-party beneficiary of this Agreement and may enforce its terms directly against User at any time.
