

# Non-Member User License Agreement for IARPA Babel Mongolian Language Pack, IARPA-babel401b-v2.0b (LDC2020S10)

\_\_\_\_\_ (“**User**”) agrees to use the data designated as **IARPA Babel Mongolian Language Pack, IARPA-babel401b-v2.0b (LDC2020S10) (the “Data”)** and distributed by the **Linguistic Data Consortium (“LDC”)** subject to the following understandings, terms and conditions.

**User** agrees to use the Data received under this Agreement only for non-commercial linguistic education, research and technology development.

**User** may include limited excerpts from the Data in articles, reports and other documents describing the results of **User’s** non-commercial linguistic education, research and technology development. Unless explicitly permitted herein, **User** shall not otherwise publish, retransmit, disclose, display, copy, reproduce or redistribute the Data. **User** shall have no right to copy, redistribute, transmit, publish or otherwise use the Data for any other purpose.

Please see the README in each delivery archive for more details on the Data.

As a recipient of the Data, **User** agrees to:

1. Insert the following statement in any product, report, publication, presentation, and/or other document that references the data: “This product contains or makes use of IARPA data, **IARPA Babel Mongolian Language Pack, IARPA-babel401b-v2.0b (LDC2020S10).**”
2. Accept the Data “as is.” **User** is solely responsible for any damage that may arise from its use of the Data. **User** agrees to hold the US Government (“USG”), the source of the Data, harmless and to indemnify the USG for all liabilities, demands, damages, expenses and losses arising out of its use for any purpose of the Data. Unless prohibited by law, **User** assumes all liability for claims for damages against it by third parties which may arise from the use, storage, or disposal of the Data, regardless of whether such liability is based on breach of contract, tort, strict liability, breach of warranties, infringement of intellectual property, failure of essential purpose or otherwise.
3. Not further distribute the Data.

LDC has entered into a License Agreement with IARPA to distribute the Data. Under the terms of that License Agreement, LDC may be required to identify recipients of the Data to IARPA.
