1.2. Summaries, analyses and interpretations of the linguistic properties of the information may be derived and published, provided it is not possible to reconstruct the information from these summaries.

1.3. Small excerpts of the Information may be displayed to others or published in a scientific or technical context, solely for the purpose of describing the research and development and related issues or demonstrating the systems under development.

2. Access to the Information by Individuals

2.1. Access to the Information by an individual person is to be controlled by that person's organization. The organization may only grant access to people working under its control, i.e., its own members, consultants to the organization, or individuals providing service to the organization.

2.2 Individuals may be allowed access to the Information only after being informed of the provisions of this User Agreement. The access is to be terminated when the conditions of the application no longer apply. The organization will retain the list of all persons ever granted access to the Information and make them available upon request to any of the copyright holders and to the institution or agency holding this completed application.
